Spaces will be assigned on a first application basis.

The undersigned below agrees to the following terms:

- 1. Liability:** The dealer agrees to be solely responsible for his/her contract, agents or assistants and releases the Raleigh Bottle Club from all claims for theft and damage to person or property from any cause whatsoever during the occupancy on or about the premises.
- 2. Table Reservations Guarantee:** Tables will be reserved on a first come, first served basis. Signed application form and fee should be received prior to the show date.
- 3. Cancellation Policy:** If cancellation is necessary, you are expected to contact Show Chairman, David Tingen (919) 848-4387 prior to the show.
- 4. Table Assignments:** Space availability is limited to approximately 30 six foot tables inside and 30 plus spaces outside (bring your own table) on the covered porch and patio. Tailgate spaces surround the paved parking area. You will receive your inside table assignment at arrival on site by the show chairman. All outside areas are first come first serve.
- 5. Refund:** Should the Raleigh Bottle Club be unable to hold the show at the location and/or date stated, due to any cause whatsoever, the dealer waives the right to any claim for damages or compensations except that the rental fee paid for the contracted space shall be refunded in full.
- 6. Valid Sale Items:** Dealer's items should be related to antique bottles, vintage advertising or small tabletop antiques. All items displayed for sale must be clearly marked with the price.
- 7. Table Surrounding:** Each inside dealer will be provided two chairs, regardless of the number of tables rented. The Show Chairman must approve any furniture other than your table and chairs in advance. Dealers will be responsible for providing their own table covering. Indicate if you need electrical hook-up so we can locate you near an outlet (dealer must furnish their own extension cord). For safety and insurance purposes, no object, sale boxes, stands, or the like are permitted in the aisles in front of the tables.
- 8. Food/Drugs/Alcohol:** No drugs or alcoholic beverages may be brought into the show area or anywhere on the premises. Food and drinks may be brought in for personal consumption, but not for sale.
- 9. Assistant/Badges:** Each dealer is allowed one assistant, regardless of the number of tables or spaces contracted. *Both dealers and assistants must wear their name badges for the duration of the show.* Only people wearing official name badges will be allowed behind the dealer tables.
- 10. Set-up Time:** Dealers can set-up Saturday, 7:00am.
- 11. Dealer Table Assignment:** For dealers that prepaid for their table, your table assignments can be obtained from the Show Chairman upon entry.
- 12. Dealer Unload/Load:** Front entrance only. Please cooperate in moving your vehicle out of the way quickly to avoid blocking other dealers.
- 13. Extra Tables:** A few extra tables may be available on a first come basis for those who didn't reserve one.
- 14. Break down Time:** The show is scheduled to end at 2:00pm and you are asked to have your tables cleared by 3:30pm.
